

“Good Touch Bad Touch” Workshop

Date: 20th May'25 and 23rd May'25

Venue: Activity Room

Classes Covered: LKG and UKG

A workshop on Good Touch Bad Touch was conducted for the students of LKG and UKG to help them understand the basic concept of body safety. The session aimed to create awareness among young children about safe and unsafe touch in a simple and age-appropriate manner.

Through storytelling, role play, and visual aids, children were taught to identify good touch (which makes them feel safe, loved, and cared for) and bad touch (which makes them feel uncomfortable, scared, or confused). They were also encouraged to follow three important rules:

- Say “NO” loudly
- Move away from the person
- Inform a trusted adult immediately

Overall, the workshop was well-received, and students participated actively. It helped build a foundation of awareness, confidence, and self-protection among young learners.
